It remains a delight to work with our Board and Professional team. Please take a moment to thank them personally for the service in helping the club and its members achieve their goals.



# Farewell to our Patron

Among the many things that make our Court and club "Royal", perhaps the most poignant has been the patronage of Her Majesty Queen Elizabeth II. Her picture (right) in the club room will remain to remind us of that support and our Royal connection. To commemorate her at this sad but inevitable milestone, we have asked RTC's historian-in-chief, David Best, to reflect on her reign and that of her royal predecessors, and for our Newsletter editor, Andy Anderson, to bring together a story befitting a monarch of 70 years' standing. I am writing on behalf of our full membership to thank them for this record and to thank Her Majesty for being our Queen and Royal Patron. Doug Sheperdigian, RTC Chairman

The Club Newsletter Number 15, dated September 1980 and typed in the style and language of that era, still exists as a historic record of a momentous day in our club's history, *writes Andy Anderson.* Read on for the full account...

**All** other events of recent months were overshadowed by the visit to the Court of Her Majesty The Queen and Prince Philip on 24<sup>th</sup> June. It was a singular honour, unrivalled in the recent history of the Club and, indeed, the game.

It also proved to be a hugely enjoyable party and was voted as an unqualified success by those fortunate enough to have been present. Much hard work lay behind that success and the club's appreciation is due to Commander Harman, the Superintendent of the



Palace, and his staff for their considerable contribution to the smooth running of the arrangements. On the Club's side the burden was carried almost singlehanded by Michael Morton, to whom must go the credit for the success of the occasion.

Thanks are also due to Henry Wollaston who, as our Chairman, was instrumental in issuing the invitation to the Queen and Prince Philip and so admirably played the role of principal host to them on the day. [Henry Wollaston stepped down following the Royal visit after nearly seven years as club Chairman, to be replaced by Ronald Swash - Editor.]

Michael Morton's efforts did not end with that evening for he has kindly also produced the account of the Royal Visit which follows here:

**The** long awaited and much heralded visit by Her Majesty The Queen and HRH The Duke of Edinburgh to Hampton Court Palace to mark the 450<sup>th</sup> anniversary of the playing of tennis at the Palace took place on 24<sup>th</sup> June 1980.

Due to the inevitable traffic jams around the Palace during the evening rush hour Her Majesty's arrival at the door to the Tennis Court from the East Front was delayed – and the weather did not exactly shine for the occasion.

The late start and the wet weather did not, however, put a damper on the auspiciousness of the event.

Inside the Tennis Court Her Majesty and His Royal Highness were first introduced to Lesley Ronaldson, Mr and Mrs Peter Dawes and Mr and Mrs Henry Johns.

The Royal party then proceeded into the dedans where, for ten minutes or so they watched (under instruction) a four-handed game of tennis then in progress between Chris Ronaldson, Alan Lovell, David Cull and David Johnson, which was marked by Derek Barrett. By all accounts this game was splendid entertainment – hard, fast and furious - and was in particular enjoyed by Her Majesty's Private Secretary, who was nearly laid low by a hard force to the dedans.

As the game ended, Her Majesty and His Royal Highness walked onto the Court where all the Professionals, who represented nearly every Court in Great Britain as well as Australia, together with the players and several members of the RTC Committee, were assembled for presentation. One professional was heard to remark that Cambridge was not the same place since the Duke's son left it - and another that he did not yet know much about the game. (This was not altogether

## A history of Royal Patrons

Although royal associations with tennis at Hampton Court go back as far as Henry VIII, it was not until 1903, soon after Edward VII came to the throne, that a reigning monarch became Patron of the Royal Tennis Court. He had learnt to play the game at Hampton Court in 1858 as a 17-year-old. Six years later he played on our court against the great world champion Edmond Barre.

Edward VII was the first of five monarchs to have been Patrons of the Royal Tennis Court. There followed George V, Edward VIII, George VI and Elizabeth II. Edward VII and George V were both playing members of the RTC and both insisted on paying five times the annual subscription.

We owe our use of Apartment 53 to George V, who was adamant that Alfred White be given the rooms when he became Head Professional. At the time the palace had wanted them for the resident electrician.

Our new King, Charles III, while at university, played at Cambridge, which is also where Prince Edward learnt to play.

Her Majesty The Queen came to the Court with his Royal Highness Prince Philip on the occasion of the Club's 450<sup>th</sup> anniversary, as outlined here. **David Best** 

surprising since he had only been in post for a fortnight!)

Television cameras had whirred on the Court, both before and after the Royal arrival and departure – the BBC filmed the entire proceedings including the party in the Cartoon Gallery for inclusion in a later Royal heritage series – and the Press were present in force. Many of the Professionals were photographed with either The Queen or The Duke of Edinburgh, and their wives and others watching from the Galleries had equal enjoyment from the proceedings and the party held in the Court afterward.

In the meanwhile, under the

television lights there had been gathering in the Cartoon Gallery some 180 members and their wives together with sundry other specially invited guests.

**Representatives from Courts** in France, the USA, Australia and Tasmania as well as from Courts in Great Britain, the **Tennis and Rackets** Association, the Lord Chamberlain's office, the Privy Purse, the game's present sponsors, Unigate, the Press and the staff at Hampton Court itself (including the RTC's own reserved 'Professionals' Mr and Mrs Evans) thronged the huge Cartoon gallery, eating and drinking whilst awaiting Her Majesty's arrival.

On leaving the Tennis Court, the Royal Party walked along the East Front to be met at the entrance to the Palace by the Chief Steward and Lady Moore and, after pausing for refreshment in one of the many rooms adjacent to the Cartoon Gallery (where further members of the RTC Committee including Howard Angus and Sir Ronald Prain with their wives, and Vernon Ely were presented). Her Majesty and the Royal Party entered the Cartoon Gallery, in keeping with the intention of the function, informally and unheralded.

For the ensuing half hour Her Majesty and His Royal Highness progressed down the length of the Gallery being introduced to various official guests either by the Chairman of the Club, Henry Wollaston or by the President of the Tennis and Rackets Association, Morys Aberdare.

What was said, what questions were asked or answered, what impressions were given or got must be the prerogative of each individual who was present. It is perhaps enough to say that the process, the first in 450 years, seemed to pass in 450 seconds.

At the end of the Cartoon Gallery, Her Majesty and HRH The Duke of Edinburgh proceeded into the Communication Gallery where, after presentation of various members of the staff of the Department of the

Before the Royal Party's final departure down the Queen's Staircase, the Chairman presented Her Majesty and His Royal Highness with engraved glass goblets to commemorate their visit and conducted them around an exhibition of pictures reflecting all aspects of the game of Tennis, which had been garnered together by Mr & Mrs Peter Railing for the occasion in the Haunted Gallery. The Cartoon Gallery, meanwhile, continued to hum with conversation. Old friendships were renewed, and tennis players the world over and their wives discussed the game, and the events of an evening which the Royal Tennis Court are proud to have been afforded the opportunity to arrange.

It would not be right if in this Report the Club forgot to express its grateful thanks to the very many members of the Staff of the Department of the Environment who coordinated all the services with naval efficiency; to the Press and television who were far less obtrusive than had been feared, and lastly to Her Majesty and His Royal Highness themselves, who graced an occasion which will not soon by forgotten by those who were present.

And finally...it was a day that our own **Lesley Ronaldson** would never forget, as she recounts: "It was a great day. I remember that Her Majesty shook my hand inside the court corridor by the back door. I was hugely pregnant with Luke at the time! It was the only time she ever came to RTC, although I met her a few times afterwards.

"When Sophie, The Countess of Wessex, brought her daughter Lady Louise as a baby to RTC she showed her our picture of the Queen and Louise repeated 'Amama, Amama!' as she pointed to it – it really was very sweet!"

## Well done our Jack!

Great news! RTC's newest Professional, Jack Josephs, has received a *distinction* for his L3 Leadership/supervisor course, part of his Investing in Professionals (IiP) qualifications.

This course is a level up on the other IiP individuals, given Jack's previous qualifications gained at University. Which confirms the strong belief, held by so many, that he has a great future in club and the RT world.

Jack said: "Over the past 18 months, I have been working towards completing my Level 3 team Leadership and Management apprenticeship and I am delighted with my distinction. At the end of October I took part in a three-hour final assessment, a 20-minute presentation and an interview, as well as discussing my studies and the portfolio of evidence that I had gathered throughout the course. I was over the moon to have been awarded a distinction in both the presentation and also the interview section.

"I am very grateful for the knowledge and experience I have gained during the course and I am hoping to use this knowledge as I progress in my role at RTC."



Where to start with the Hampton Courtiers' (representing RTC) five-day campaign in the Tournoi Trois Tripos (TTT) doubles tournament in a glorious corner of Basque countryside in SW France, other than to say that the team won the much prized Coupe d'Arcangue?.

The Hampton Courtiers team was made up of Geoffrey Russell, Rhona Russell, Julian Sheraton-Davis, Linda Sheraton-Davis (capt), Lucy Hutchinson and yours truly, plus our "artist in residence" Francesca Learmount painting watercolours of the courts and matches we played during the tournament.

The tournament feels very similar to the biannual Boomerang at Royal Melbourne Tennis Club. In TTT has 20 teams competing with players from all over the globe (US/Australia/France/UK/ the Netherlands/Ireland). It is similar also in terms of the group stages with matches played on a round-robin basis. There comparison starts to fade, as TTT is set around the city of Bayonne (next to Biarritz) where historically there has always been a strong relationship between this part of France and Britain and probably where jeu de paume (tennis) found its way to Britain.

The TTT court locations are in the most picturesque French Basque countryside around Bayonne, la Bastide-Clairence, Urrugne & Bidarray. Geoffrey Russell had the responsibility of team selection and running order which needed to be confirmed in advance to the TTT organisers the Simons (messrs Mansfield & Berry) by 7.30pm every day. I should add our congratulations to the organisers Simon Mansfield, Simon Berry & Isabelle Riou for running such a large and complex tournament.

The Hampton Courtiers visited the Bayonne court (called Trinquet st Andre) on our first night. It is in the oldest part of the city on the Rue de jeu de paume. The court is small, the roof is wooden as are the viewing galleries. The back wall at the hazard end has no penthouse and there is no tambour as on a RT court. The penthouse only runs along two sides and is lower and narrower and the floor is rough concrete. These features would typify all the courts we played in the TTT.

This visit gave the Courtiers much to think about in terms of tactics. We started our campaign in the beautiful village of Bidarray, close to the Spanish border. The court still came as a shock as it was tiny . The penthouse roof appeared even narrower than Bayonne and the bobble serve reigned supreme over the railroad. It proved a steep learning curve (without having time to practice with the fluorescent orange Real Tennis balls!) against an experienced Prested Bleu side and despite a combative performance we lost. The Courtiers returned to Bidarray the following day to take on the Royal Dutch team led by Theo Bollerman, another TTT veteran. Although picking up our first game win the Royal Dutch team prevailed in a close encounter.

Scheduling stepped up a gear the next day with matches v Queens at Bayonne and against Petworth at la Bastide-Clairence (and although there were no overall team wins for the Courtiers our performances continued to improve significantly.

Hampton Courtiers needed something special in the final round of matches and found inspiration in Urrugne with a convincing win over Jesmond Dene, followed in our final group match in Bayonne by another big win against the unbeaten Oxford Unicorns which put Hampton Courtiers into the quarter final of the Coupe d'Arcangues.

A special mention for the team of markers at the TTT, led by Real Tennis and rackets legend Howard Angus, who all had the unenviable task of making the right calls on courts. This included the courts measured in Napoleonic feet (an actual, ancient system of measurement) plus the very faded markings on the court. This occasionally led to some interesting calls, and the use of gaffer tape to highlight particularly faded floor markings! Hampton Courtiers entered the quarter final against Royal Melbourne Tennis Club (all the finals games played at the la Bastide-Clairence court) and won a tough match to set up a semi-final with Prested Blancs. This proved an equally tough encounter but Hampton Courtiers found a way to win and make it to the final, where Middlesex (MURTC) awaited. The match could not have been closer and went to games count-back to decide the winner, where HC triumphed 20-15 to lift the Coupe d'Arcangues - a deserved reward for a magnificent team effort throughout the tournament.

Alas, I could not stay for the finale which included the gala dinner hosted by the Marquis Michel d'Arcangues at his chateau (for which many thanks) and the presentation to Hampton Courtiers of the Coupe d'Arcangues. My fellow courtier Geoffrey described TTT as this "most extraordinary event" – an observation with which I believe all the competitors in the 2022 TTT would concur. Planning starts now for 2024!!
